**Share Price Closes Strong on First Trading Day  
46.7% Higher than Offer Price**

(Hong Kong, 15 October 2019) – Shares of **EuroEyes International Eye Clinic Limited** (“**EuroEyes**” or the “**Group**”), one of the leading brands in the vision correction industry with German ophthalmology excellence, have commenced trading on the Main Board of The Stock Exchange of Hong Kong Limited (“SEHK”) today, under the stock code 1846.

Shares of EuroEyes were actively traded today and recorded satisfactory price performance. The intra-day high was HK\$15.18, 102.4% higher than the HK\$7.50 per share offer price. The closing price was HK\$11.00, 46.7% higher than the offer price. A total of approximately 9.911 million shares were traded, with total turnover reaching approximately HK\$1.24 billion.

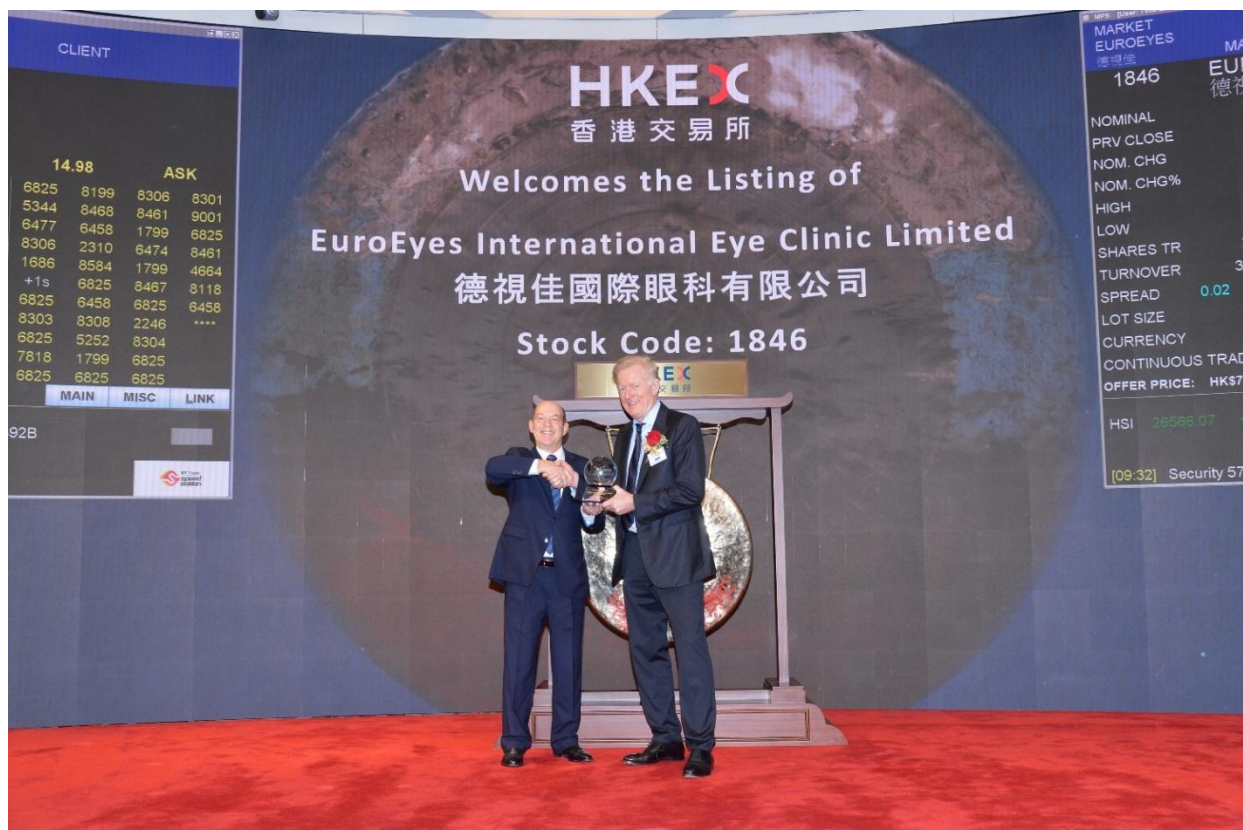
